


"I often use the public library data to defend my budget to town officials.

It is also useful for making comparisons with other libraries. I like to use graphs and other visuals to show where the library stands in comparison with others, and to show how much the public is using us. When I first arrived in Millis I created a "State of the Library" PowerPoint which I now give each year to Fin Comm, Selectmen, and anyone else who will listen. The public library data is an important source of info for these presentations."



HOW DOES WAKEFIELD'S LIBRARY RANK STATEWIDE?





"I always bring comparison charts to meetings with the Town Finance Committee. It gives them context about the true cost of running a library, and when the see the amount that the Library contributes to its budget (via fundraising and endowment income), they approve our appropriation with little discussion and much praise.

Our Long Range Plan always includes information from the Library data, as well, particularly the service information, showing increases during the previous Plan's years, to support our future plans. As an appendix to the Plan I include bar graphs made with your chart tool, comparing us with our closest neighbor libraries (Orleans, Brewster, and Harwich) in the areas of Library attendance, number of programs held, and direct circulation.


The rankings report is also very helpful; our Development Committee loves to cite those numbers in their fundraising materials, and feels they are a big factor in our growing support."



"I also want to let you know that I have used public library data in ways that didn't necessarily end up on funding requests but still informed my decisions. I used salary information to set decent starting wages (\$13.48/hr) for the library assistants this year's budget allowed me to hire -- so I can attract people capable of helping continue Hadley's progress; I have used education levels to support staffing decisions and to point out past inequities in pay; I will continue to use staffing levels in advocating for off-(circ)desk hours for the director. Finally, I have colleagues (who shall remain nameless) who use salary data for jobhunting purposes."


